- 1) **INTRODUCTION:** The Summit at Fritz Farm Punch Card sweepstakes ("Sweepstakes") is offered and sponsored by Fritz Farm Retail Company LLC ("Sponsor"). The Sweepstakes is governed by these official rules ("Official Rules"). By participating in the Sweepstakes, each entrant unconditionally agrees to be bound by and comply with these Official Rules (including all eligibility requirements) and the decisions of Sponsor, which shall be final and binding in all respects. The Sweepstakes is subject to all federal, state, and local laws and regulations and is void where prohibited by law. This giveaway is a sales promotion for The Summit at Fritz Farm, 120 Summit at Fritz Farm #155, Lexington, KY 40517.
- 2) **PROMOTION PERIOD:** The Sweepstakes begins at 11:00 AM Eastern Standard Time on Saturday, August 1, 2020, and ends at 8:00 PM Eastern Standard Time on Monday, August 31, 2020 (the "Promotion Period"). Sponsor is responsible for the collection, submission and processing of entries and the overall administration of the Sweepstakes. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes.
- 3) **ELIGIBILITY:**
  - A) The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry.
